ESAFF Uganda, through the Land Rights Support Centre (LRSC), with support from Oxfam in Uganda, in partnership with the Ministry of Lands, Housing and Urban Development, will host "The Land Camp" at Logiri Subcounty, Arua District, to respond to the rampant land related conflicts and issues reported in the subcounty and the neighboring areas and gaps in access to land justice and raise community awareness on land rights.

Since 2011, Land Camps have served as mobile community legal spaces, bringing justice and credible land information closer to citizens. Through activities like community dialogues, mobile legal aid clinics, and radio talk shows, past camps identified persistent challenges such as weak capacity within Area Land Committees and insecure land tenure for women. In response, the Land Camps created a platform for solutions — strengthening land governance structures, supporting women to process land documents, and amplifying farmer voices in policy processes. To date, the initiative has reached 19,726 citizens, provided legal aid to 582 people, conducted 304 mediations (64% resolved), and enabled 20 women-led households to secure land documents.

ESAFF Uganda has organized Its 4th Land Camp in Logiri Subcounty - Arua District, Uganda from 24th to 25th September 2025 to strengthen community awareness and capacity to secure land rights stemming from the rampant land-related conflicts, resolve or refer land disputes through timely and accessible support as well as link land rights to broader health and wellbeing in rural communities.

"The past land camps have opened our eyes to the laws that protect us as small-scale farmers, especially as women. Before, most of us did not know we had a right to be consulted when land decisions were made in our communities. I believe organizing the 4th land camp will bring together even more farmers to learn, share experiences, and find solutions to the increasing cases of land conflicts and evictions we face every day."

At the 4th Land Camp activities will include:

- Legal Aid Clinics Free legal advice on land rights, disputes, and documentation.
- Awareness Sessions Community education on land laws, policies, and procedures.
- Land Information System Viewing Supported by MLHUD for land title search and verification.
- Alternative Dispute Resolution & Case Referrals On-site mediation and linkages to institutions by the Lawyers.
- Radio Talk Shows & IEC Exhibitions Discussions and information sharing on topical land issues.

To make the 4th Land Camp more holistic and inclusive, ESAFF Uganda will also run:

- Blood Donation Campaigns in partnership with the Arua Blood Transfusion Services to boost healthcare services.
- Women's Shelter & Counselling Sessions supported by the ESAFF Women's Forum and Action Aid Uganda for psychosocial safe support.
- HIV/AIDS Testing & Counselling in partnership with the Arua Regional Referral Hospital, with free, confidential services.
